## **Youth Board Tours Hardy** Offices, Learns Dangers Of Texting While Driving

Hardy's Youth Advisory Board took an in-depth tour of Hardy's Lost River headquarters during a meeting on December 22, and the group discussed the dangers of texting while driving.

Hardy Project Manager Bobby Armistead explained the capabilities of the company's central office switch, which essentially is the brains of Hardy's operation. The central office switch is the mechanism that routes all calls to their appropriate location. Hardy currently is installing a new Metaswitch unit, which is software-based and will greatly enhance the calling features and other services that Hardy can offer.

Bobby then led the group to Hardy's battery room, which houses the batteries used as back-up power in the event of an electrical power outage. The electricity needed to power Hardy's machinery is somewhat like running your clothes dryer 24 hours a day, seven days a week, he said. The equipment generates so much heat that air conditioners must run around the clock or else the batteries may overheat, he said.

After the tour, the students watched a documentary short film titled "Distracted: The True Story of Ashley Umscheid".

Ashley Umscheid was a 19-year-old Kansas State University freshman who was killed in May 2009 when her vehicle crashed along a Kansas road. The investigation revealed that she had been sending text messages on her cell phone while driving. The Foundation for Rural Service released the film in an effort to warn teens about the dangers of distracted driving.

Board member JoBeth Delawder, a Moorefield High School freshman, said the film had a valuable lesson for young drivers.

East Hardy High Seniors Jesse Cook and Ashlev Dove participated in the 2010 Youth Tour. Both students said the trip was a wonderful experience and encouraged others to apply.

This year's preliminary agenda includes visits to the

U.S. Capitol, the Lincoln Memorial, the World War II Memorial, Mount Vernon (home of George Washington), the Vietnam War Memorial, the Smithsonian Museums, the Korean War Memorial, the National Zoo, the National Cathedral, and Arlington National Cemetery.

Applications for the tour may be picked up from the guidance counselors at both high schools or by contacting Derek Barr at Hardy's offices. To be eligible for the trip, students must be high school juniors of the 2012 graduating class, be either 16 or 17 years old at the time of the tour and

receive service from either Hardy Telecommunications or HardyNet.

The deadline to return applications is February 11, 2011. Applications may be returned to either the high school guidance counselors or directly to Derek.

## Hardy Sponsoring 2011 FRS College Scholarship

Hardy Telecommunications is sponsoring the national Foundation for Rural Service 2011 College Scholarship Program to graduating seniors at Moorefield and East Hardy high schools.

The scholarship, open to applicants who receive telecommunications service (either telephone or Internet) from Hardy, is worth \$2,000, and Hardy Telecommunications contribute an additional \$500 to the amount, bringing the total one-time scholarship award to \$2,500. Interested students can contact their guidance counselors at the two schools or download the application at the FRS website at www.frs.org. Students are asked to return their applications no later than February 11, 2011. Applications should be returned to the guidance counselors at Moorefield and East Hardy high schools or to Derek at Hardy's offices.

The FRS will award 30 scholarships nationwide. qualified selection committee of current educators determined by FRS will select the winners; Hardy Telecommunications itself has no input in the process.

Applicants must be accepted by an accredited two- or four-year college, university vocational-technical school; have at least a C grade point average; express an interest in returning to a rural community following graduation; and be sponsored by an FRS contributor.

#### **Hardy Granted TV** Agreements For OneNet Fiber

Hardy Telecommunications has had television franchise agreements approved by Hardy County and the towns of Moorefield and Wardensville.

The franchise agreements are the first steps necessary for Hardy to begin offering TV service as part of its Hardy OneNet Fiber-to-the-Home project. Funded by a \$31.6 million grant/loan award from the federal government, Hardy will build fiber-optic connections directly to consumers. The fiber network will allow Hardy to offer high-definition TV with local channels such as WHSV-TV3, faster Internet speeds and digital voice service.

Hardy General Manager Scott Sherman said the fiber buildout will take three years, but he hopes the first round of customers should receive service in late summer 2011.

## **Hardy Completes Alternate Internet Route**

HardyNet recently completed work on an alternate route for its Internet service that greatly increases reliability by providing a secondary pathway for Internet traffic if the main route is unavailable.

The project's completion means that if HardyNet's main network path to the rest of the world is not operable, Internet traffic automatically is transferred to the alternate route so that customers do not see any disruption in service. Previously, HardyNet had only one route for its Internet traffic; if that network was not working, all of HardyNet's customers would lose service. HardyNet Marketing/Human Resource Director Derek Barr said the new route provides a back-up path.

"Our goal as an Internet service provider is to offer as reliable a network as possible, and this alternate Internet route is a critical part of that process," he said.

As an Internet signal, or a telephone call, leaves the Hardy County area, it must travel over other companies' networks to be completed. Hardy Telecommunications has had multiple paths and back-up plans for other services, such as long distance calls, for quite some time, but Internet traffic had only one route. Now, if necessary, HardyNet traffic has multiple routes on which it can travel.

Derek said the new route was completed in conjunction with Shenandoah

Telecommunications The traffic (Shentel). connects with the Shentel network on its way to the rest of the world. Final testing on the new route was completed December 14.

"We had our people and Shentel representatives monitoring the test, and everything worked just as we hoped it would," Derek said. "(Hardy Telecommunications Central Office Supervisor Bill Schmidt) said there was no drop in our Internet connection or Shentel's services when the test was performed, both switching from the primary route to the secondary route and switching back from the secondary route to the primary route."
